 - g) Revise Standing Rules to apply Bylaws item regarding absences to Committees as well
 - h) Consider creating a Standing Rule to require repopulating all Committees after new Executive Committee is elected after Board elections
 - i) Create Standing Rule to define protocol when more than 9 Board members &/or stakeholders want to join a committee
 - i) Require EDLU and Grants & Funding Committee members to take DONE Ethics training
 - j) Consider removal process for Committee members

 - k) Revise Bylaws regarding alternate Board members
