Councilmember Cedillo:

The Glassell Park Neighborhood Council (GPNC) has voted unanimously to support the new Community-based, Community-oriented LAPD Station/Northeast Division with a (800 s.f.) **Community Room** proposed at 3353 San Fernando Road as per Department of City Planning **Case No. DIR-2013-147-PUB-CDO-CLQ-SPR** to service the (21) neighborhoods found in the Northeast Los Angeles Area of the City of Los Angeles.

The GPNC believes it is our duty to protect the interest of our NELA neighbors that will use the new facility given that it will be located in Glassell Park. We need your assistance to help us protect their interest and to be implemented as follows:

“That eighteen (18) parking spaces, - including one (1) handicap stall, and one (1) van accessible stall - be provided to serve the (21) neighborhoods utilizing the proposed community-based/community-oriented policing facility.”

The (9) proposed parking spaces are not enough to serve the Northeast, Central & East Neighborhoods given that there currently exist **24 total parking spaces available - (8) parking spaces at the front and (16) parking spaces located along Treadwell Street.**
