During the winter storms earlier this year, some erosion occurred to a steep hillside adjacent to Cazador Street in Glassell Park. At the request of Council District 1, the Department of Public Works was asked to perform an investigation into the storm-related damage at the site. Subsequently, an official from the Bureau of Engineering (GEO) performed an investigation with a series of recommendations contained in the following report:

Field Investigation, 14-034. Conducted 3/13/14. -- Cazador Street at Loveland Drive & Brilliant Way


Since the hillside communities in Glassell Park have historically been prone to storm-related damage we are concerned about the future integrity of this vital residential thoroughfare and essential emergency vehicle arterial road that serves our hillside residents.

The Glassell Park Neighborhood Council respectfully requests that a knowledgeable authority appear at an upcoming Glassell Park Neighborhood Council Land Use Committee meeting to brief the Committee on the investigation, findings, and potential remediation regarding this roadway and potential hazard.
