At its meeting of August 14, 2014, the Economic Development and Planning/Land Use Committee received a presentation by Jeremy Raub, owner of the Eagle Rock Brewery located at 3056 N Roswell Street.

- --Committee discussed application; a renewal of a conditional use permit for on and off-site alcohol sales with no change of operations or conditions requested by applicant
- --discussion ensued on issues of concern for both the brewery and Committee members
- --most of the concerns have to do with enforcement of homeless people loitering, dumping, littering, problems that were there before the brewery opened
- --Committee members and Mr. Raub felt application was an opportunity to educate community about calling for bulky item pick up and monitoring of streets such as Delay (next to Brewery)

A motion was adopted by the Committee to support renewal of application and that the length of the conditional use be 10 years instead of 5 and that operating hours be extended past 10pm.
